SNAP receives grant from Nestle Purina

Christmas came a little early when we received a grant from Nestle Purina on December 21, 2005. \$3,160 was given to SNAP for a single-parent hardship fund.


The average monthly household income of SNAP clients



is only \$946. For single-parent families, however, the financial situation is often more dire with an average household income of only \$785. In the coming months, the money so generously provided by Purina will fund 70-80 surgeries for families who would not otherwise be able to afford to have their pets fixed.

Lessons Learned from Katrina Proposed Pet Evacuation Bill Among New Ideas

The heartbreaking pictures and stories of the devastation no longer appear on the nightly news. It's a new year and we are all maxed-out on holiday cheer, credit cards, natural disasters and wars.

We're ready for a fresh start and high hopes for a much better year – right?

Meanwhile, we read in the latest issue of *Best Friends* Magazine that people are still working to rescue the animals roaming the streets in the devastated areas of New Orleans and other Gulf Coast cities. Displaced pets in the hundreds roam the streets, some hiding because of fright or injury. The workers are

faced with the challenge of keeping the animals alive until the overcrowded shelter facilities have space to take them. They routinely place food and water in the destroyed neighborhoods to keep the animals alive.

After the hurricane, there was an unprecedented outpouring of financial support for national animal welfare groups. According to Paul Berry, Best Friends Director of Operations, the public's response to Katrina created an opportunity for a



more progressive method of animal care, including spay/ neuter clinics and shelters designed for adoption rather than euthanasia. "It was the silver lining in

the cloud of catastrophe: the chance to build an entirely new approach to animal care and control to a region that had resisted spay/neuter, adoption and other no-kill programs."

Unfortunately, these plans for the future must be put on hold because of the numbers of displaced pets still roaming the streets. Growing up without



human contact on the streets, they can grow into packs of feral dogs and cats, enlarging the cycle of pet overpopulation, homeless pets and ultimately euthanasia.

> What lesson can we take from this? As animal lovers, we know how difficult it is for you to see and hear about an event that causes such widespread suffering to our best friends. Instead of resting easily here in sunny Missouri as we enjoy our own four-legged families, let us be proactive in honor of the Katrina animals.

If you haven't already, we urge you to 'spread the mes-

sage' that spaying and neutering is the best opportunity we have to stop the overpopulation and killing of animals. Until the *entire* Ozarks community gets that message, we will continue to be part of the problem instead of the solution.

Another lesson learned from Katrina is how important pets are to their families. If you're reading this newsletter, you already knew that, but apparently some people did not! Evacuation plans separated people from their pets, a mistake that was not repeated when Hurricane Rita struck a few weeks later. In fact, on September 22, 2005, just two days before Rita came ashore, U.S. House Representatives Tom Lantos (D-California) and Christopher Shays (R-Connecticut) introduced the Pets Evacuation and Transportation Standards Act (PETS) bill into Congress. The bill would require the government to include animals in future emergency evacuation plans.

None of us can comprehend the devastation that awaited animal welfare groups in those days and weeks following Katrina. But what we can do is *not forget*. There is much work left to be done. 
